"Quotation for e-repository system" invited from competent companies by The Indian Institute of Metals (for Digitized Library).

#### **Description of the IIM Library**

IIM Library has over 1000 titles spanning across Text books, reference books, Foreign Conference Proceedings, Conference Proceedings organised by IIM Chapters, Bound Volume Journals, IS Standards, Souvenirs/ Abstracts of NMD-ATM event of IIM etc.

DSpace DMS software has been deployed for the Library Digitization Project as it can be hosted on any local server or cloud server architecture. The DSpace DMS platform is scalable up to million users and environment. For this digitisation, IIM has installed local server with Xeon Processor 16 GB RAM, 2TB HDD (RAID for SATA drive) using UBUNTU os.

#### **Current status of the IIM Library**

Around 10L pages have been scanned and uploaded in the UBUNTU server.

#### **Requirement Criteria**

When a page of an article/book is opened for the reader in .pdf form, the reader should only be able to **Read** the content. **Copy, Download, Print-screen** and **Print** facility must be disabled for reader/everyone.

#### **Reference Criterion**

Minimum of three customers' references using the software/plugin (sold by the bidder) at least for 12 months successfully must be shared. Photocopy of POs and customer testimonials should be made available by the bidder.
